The matters to be considered at such closed session are as follows:

- 1. Legal actions, cause of action, or litigation involving the district and any confidential or privileged communications between the district or its representatives and its attorneys. 610.021(1)
- 2. The lease, purchase or sale of real estate by the district where public knowledge of the transaction might adversely affect the amount to be received or spent by the district. 610.021(2)
- 3. Hiring, firing, disciplining or promoting of particular employees by the district when personal information about the employee is discussed or recorded. 610.02(3)
- 4. Proceedings involving the mental or physical health of identifiable individuals. 610.021(4)
- 5. Scholastic probation, expulsion, or graduation of identifiable individuals, including records of individual test or examination scores. 610.021(5)
- 6. Testing and examination materials until the test or examination is given for the final time. 610.021(6)
- 7. Welfare cases of identifiable individuals. 610.021(7)
- 8. Preparation on behalf of the school district or its representatives for negotiations with employee groups, including any discussion or work product. 610.021(8)
- 9. Software codes for electronic data processing and documentation thereof. 610.021(9)
- 10. Competitive bidding specifications until officially approved or published. 610.021(10)
- 11. Sealed bids are related documents until the bids are opened; sealed proposals and related documents until all proposals are rejected; or any documents related to a negotiated contract until a contract is executed. 610.021(11)
- 12. Individually identifiable personnel records, performance ratings and records pertaining to employees or applicants for employment. 610.021(12)
- 13. Records protected from disclosure by law. 610.021(13)
- 14. Scientific and technological innovations in which the owner has a proprietary interest. 610.021(14)
- 15. Records relating to municipal hotlines established for reporting abuse and wrongdoing. 610.021(15)
- 16. Confidential and privileged communications between the Board and its auditor, including all auditor work product. 610.021(16)
- 17. Operational guidelines and policies developed, adopted or maintained by the district for use in responding to or preventing any critical incident that is or appears to be terrorist in nature and that has the potential to endanger individuals or public health or safety. 610.021(17)
- 18. Existing or proposed security systems and structural plans of real property owned or leased by the district where public disclosure would threaten public safety. 610.021(18)
- 19. Records that identify and would allow unauthorized access to or unlawful disruption of the configuration of components or the operation of a computer, computer system, computer network or telecommunications network of the district if released. 610.021 (19)
- 20. Credit card numbers, personal identification numbers, digital certificates, physical and virtual keys, access codes or authorization codes that are used to protect the security of electronic transactions between the district and a person or entity doing business with the district. 610.021 (20)
